OVERVIEW

The Protocol is designed to transform existing health care billing, claims payments and data related practices to facilitate cost reduction, improve patient privacy and access to their data and its benefits, provide new tools to identity pandemic related changes in health-related analytic norms, and to enable changes in recent legislation and regulations to facilitate increased access to health services, with an objective of increasing wellness and vitality in natural persons.

PATIENT CENTRIC

A key focus is a patient-centric record of a natural person's health status and history, which may be shared with applicable providers and benefit from their records. The Protocol recognises the unique interests that patient and providers have in the combined data and the need for personal privacy of the patient. Benefits related to sharing anonymous data is also a key focus, particularly for life insurance companies and pension funds, given the increasing anomalies developing in historic mortality, morbidity and health related claims as a result of COVID 19 and variants.

The Protocol is designed for patients to participate in financial benefits of their data.

The Protocol is designed to enhance local community DX - Digital Transformation and Environment | Social | Governance ("ESG") initiatives, in conjunction with O|Zone™ Community PPPs.

THE PROTOCOL

The Protocol is designed to commence with a highly specialised development of a "living" health record of each participating HUMAN, designed to create a Digital Thread lifecycle approach to monitoring and analysing human health and the impact of treatment through time. The "containerised patient module" may be persisted on their mobile device providing instant access to medical records and conditions to connected doctor's, hospitals and patient healthcare providers. From this core component flows a wide range of products and services to be incrementally introduced.

THE PATH TO IMPLEMENTATION

A patient is provided a digital wallet, similar to a bank account app on their mobile device, along with an initial allocation of HGVS. The wallet is designed for acquisition, storage and retrieval of healthcare information, insurance coverages, doctor's appointments, etc. For patient's who wish to participate in global health initiatives, on an anonymous basis, their wallet may receive additional HGVS with health care services and data shared with these programs. HGVS may pay deductibles, lower health costs, and may be transferred to Community FlexRewardsTM programs to use with local merchants.



HGVS ISO

ADC PRINCIPALS are associating HGVS™ Protocol with a bespoke International Sponsor Organisation ("ISO"), established by five international non-profit foundations to facilitate implementation of **HGVS** Protocol and affiliated operations. This **ORGANISATION** is designed to foster development, awareness and uptake of core HGVS objectives in countries globally. It's operations are overseen by a Board of Directors under auspices of its Board of Governors, Directorates and members of HGVS Society™...

HGVS ISO

This non-profit owned organisation adopts Alliance iii.o Collobarative Components organisational model to facilitate sponsorship of Digital Infrastructure Utilities, Digital Assets Organisations, Digital Units Organisations, other integratable Components and Decentralised Automous Organisations.

HGVS™ ECOSYSTEM

HGVS™is designed as a DIGITALUNIVERSE Ecosystem, a form of Community-centric ORGANISATION designed to benefit its participants. It is comprised of several Decentralised Autonomous Organisations (each a "DAO"), private currencies and other forms of digital assets, and configurable Components.

HGVS Digital Assets | private Currencies provide new technology implementations of traditional concepts, enabling medical providers to address pricing | payment issues within medical billing | healthcare, using "rewards" programs to evolve provider | client relationship to a "preventative" model.



AGM Anonymous Global Money - Digital Currency

ALLIANCE III.O has established the AGM Primitive and Protocol for the purpose of creating a private ecosystem based digital currency for use in buying and selling goods and services within the ecosystem. AGM are supported by a basket of global fat currencies and other assets. Their objective is to be pegged to a basket of fisc currencies, government bonds, global indicators and other criteria established from time to time and published as a currency index.



The LIVECURRENCY. Primitive and Protocol is designed in a manner similar to streaming stock quotes, video and other streaming applications. This concept could be applied to time base billing services, such as professionals, etc. It involves a stream and one or more pools. In addition, it could be an interesting means of creating continuous money that has its return adjustment period duration substantially reduced. It may support bidirectional volume. HGVS[™] Digital Assets - Digital Currency Protocols

HGVS™ may be issued as private digital currency, similar to travel industry rewards.

HGVS[™] may be awarded to patients by medical providers as part of their participation in medical research, upon receiving patient services and for joining anonymous data contribution programs, in which patients earn HGVS[™] for participating in the programs.

Medical providers acquire HGVS[™] to pay for their participation within HGVS[™] network.

COMPONENTS ARCHITECTURE

The initial phase focuses on acquisition of hospital receivables denied by applicable claims payor. Using Digital Transformation advanced ai, Medicare Subject Matter Experts anticipate substantial recoveries.

The first Initiative is currently underway regarding healthcare accounts receivable recoveries. Various necessary components | configurations and staffing resources are described.

Identity | Secure | Addressable - Crowd Sourced | REGULATED

At the core of patient privacy is identity, security and addressability. The Digital Infrastructure is designed to benefit from crowd source identity and regulated quantum id, security and network.



USD\$500 Million FlexGIATM - HGVS™ SERIES

Formation of new US Healthcare IAC™ Cube, issuance of USD\$500 million FlexGIA™ to fund Recovery Receivables debt warehouse, Custodian, Issuance Professionals.



Risk | Assets | IPTM | International Repository Facility

This Digital Infrastructure Utility ("DIU") acts as a transaction closing facility for large institutional transactions and as a securities repository, similar to DTC, EuroClear, and Clearstream.



CDO Partners I SPU - IDX DIGITAL DEBT WAREHOUSE

This special purpose digital repository, a Digital Assets Organisation ("DAO""), is owned by non-profit foundations, operated by regulated bank trustee | custodians and facilitate international transactions.



International Debt Facility - IDF REPOSITORY

These special purpose custody facilities, Digital Infrastructure Utilities ("DIU"), are owned by non-profit foundations, operated by regulated bank trustee | custodians and facilitate international transactions.

CORE INFRASTRUCTURE COMPONENTS - DOMESTIC



Directed Portfolios Facility™

Each DPF represents a trust | custody | segregated portfolio (Series) facility designed to enable banks to benefit from recent Volcker Rule Amendments. These facilitate HGVS payment receipts.



HGVS Outsourced Services Provider Platforms

The Principals have access to more than 100 programmers, subject matter experts and healthcare professionals with deep expertise in claims recovery and hospital systems.
